Part 1

Introduction

This is the publication scheme operated by the English Institute of Sport. Under the Freedom of Information Act 2000, the English Institute of Sport (EIS) as a public body is required to produce a publication scheme setting out what information it will routinely make available, how and when it will do so, and whether this information will be available free of charge or at a cost.

The EIS provides sports science and medicine services to athletes through a network of sites throughout England.

The EIS receives grant funding from UK Sport through the National Lottery. The EIS is a limited company with UK Sport as its sole member.

It aims to provide the public with a simpler means of obtaining information and reduce the need for EIS to respond to requests for information made under the general right of access to information provided under section 1 of the Freedom of Information Act.

The EIS is committed to making the information contained within the scheme routinely accessible, and to review the scheme periodically.

How are items published?

Many items are available to download from our web site, www.eis2win.co.uk and are available in hard copy from the address above. Some items are only available in hard copy at present although we intend to make as much information as possible available electronically.

Feedback

We have published the scheme because it is a requirement of section 19 of the <u>Freedom of Information Act 2000</u>. The purpose of the Act is to promote greater openness by public authorities (i.e. government and other public sector organisations). It is important therefore that the scheme meets your needs.
